2. CONTRACT PERIOD, AMOUNT AND OTHER TRAVELLING EXPENSES;

The candidate shall be appointed on Contract basis for a period of one year. Renewal may be possible at Bank's sole discretion in terms of extant policies and rules.

3. CONTRACT AMOUNT AND OTHER TRAVELLING EXPENSES;

The contract amount shall be fixed as the last pay and allowances drawn by the officer less the initial amount of pension fixed before commutation plus relief etc. payable thereon OR Rs. 15,000/- per month, which ever is lower.

Further a lump sum amount of Rs.500/- per month shall be paid towards mobile, conveyance etc.

No diem allowance shall be payable where vehicle is provided & Rs.300/- per day diem shall be payable where vehicle is not provided.

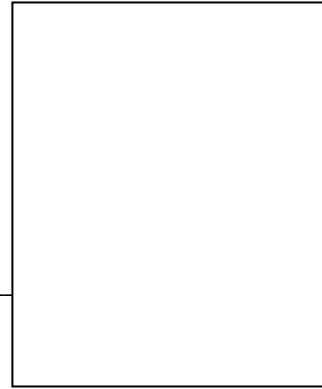
