Except for the post of security in Scale II and I age relaxation of 10 years (15 years for SC/ST & 13years for OBC) is applicable to PWD candidates in conformity with the PWD Act, 2016. However, the upper age limit of the applicant should not exceed 56 years.

Two categories have been added viz. (1) Credit officer Scale-II and (2) Economist Scale-II.
