- 4. The average annual turnover for last three financial years shall not be less than ₹7.50 Crore
- 5. The contractor must have previous experience of constructing minimum Gr. + 4 storey's buildings.
- 6. Contractors having registered with ISO 9001:2008; PWD/CPWD under appropriate category would be given additional weightage for pre-qualification
