Offer letter may be send by post or by hand.


2. The application for purchase of the vehicle should be submitted in the prescribed format available at our office during office hours at a price value of Rs.200/- (Rs. Two hundred only) or may be downloaded from bank website www.centralbankofindia.co.in and submit the same along with application fee. **Application fee will be non-refundable. Application submitted without applicable fee will be rejected and no correspondence will be entertained.**

3. Application will be free of cost for bank staff/ex-staff members.

4. The Duly filled up form in the prescribed format in sealed envelope be addressed to the ASST GEN MANAGER – BSD, Central Bank of India, Zonal Office- DELHI, PLOT NO. 04, BLOCK NO. 54, DESH BANDHU GUPTA ROAD- KAROL BAGH, DELHI-110005
5. All the application must be accompanied by DD (application fee & EMD) , drawn in the favour of Central Bank of India, Zonal Office- DELHI, Payable at D B GUPTA RAOD, KAROL BAGH – DELHI.
6. Earnest money deposit (EMD) will be Rs.5000/- for Central bank staff/ex-staff and Rs.10000/- for general public, which will be refunded to unsuccessful bidder after completion of sale process.
7. Bank Can cancel the tender without any prior notice if require.
8. The purchaser can withdraw his or her offer before opening the offer but application fee will be forfeited.
9. The right for accepting or rejecting the offer is sole discretion of the Management of Central bank of India.
10. Highest bidder will have to pay the entire cost of the vehicle, along with applicable GST (18%, EIGHTEEN PERCENT) in lump sum at our office by way of Demand Draft/NEFT or else his earnest money amount (EMD) will be forfeited.
