1. Central Bank of India invites offers from interested parties who intend to purchase Bank's vehicles, details of which are mentioned below, on "As Is Where Is Basis". Offer Document can be obtained from the office at below mentioned address during working hours of the office (1000 Hrs to 1700 Hrs). An application fee of ₹ 1,000/- (Rupees One Thousand only) per vehicle for General Public by means of a Demand Draft (DD) or Pay Order in favour of Central Bank of India and payable at Mumbai must be submitted along with the bid. Application fee is not charged for the staff and ex-staff. Alternatively, the forms can be downloaded from Bank's website www.centralbank.co.in under Tender Section. The application along with prescribed documents should be submitted at our following address:

- 3. **Opening of Tenders & Validity Period**: The bids are to be submitted by 1500 Hrs on 28 Oct 2022. The interested tenderers may remain present during the offer opening process at the scheduled date and time. The offer will be valid for a period of two months from the date of receipt of offer by successful bidder to enable the office for observing all necessary formalities.
- 4. **Inspection of Vehicle**: Interested tenderers may inspect the vehicle with permission at the Central Bank of India, Mumbai Metropolitan Zonal Office at the said address on any Bank Working Day between 1000 Hrs to 1600 Hrs up to 27 Oct 2022.
- 5. A separate bid must be submitted for each vehicle in which the bidder is interested and an envelope that must be super scribed as "Bid for purchase of vehicle". Registration No e.g. MH-01 AV-5332. **BID WOULD BE EXCLUDING GST**.
- 6. Earnest Money Deposit of ₹ 10,000/- (Rupees Ten Thousand Only) per vehicle for General Public and ₹ 5000/- (Rupees Five Thousand Only) for Staff and Ex-staff shall be paid along with the offer. The DDs/ Pay Orders for application (as mentioned in Para 1 above) and EMDs must be enclosed with the Bid. The successful bidder has to pay the full amount for each vehicle less amount of EMD for each vehicle within Seven days from the date of receipt of intimation (Excluding the date of intimation) by means of DD/ Pay Order favouring Central

Bank of India and payable at Mumbai. Failure to make payment of the full amount in time may result in forfeiture of the offer to purchase the vehicle as well as the EMD submitted. **Application forms without application fee or EMD will be rejected**. Presence of respondents during the opening of the tender on the appointed date and time will be allowed and they will be informed about the same through Letter/ email.

7. **Bids below 'Reserve Price' will not be considered. The 'Reserve Price' will be declared at the time of opening of the Bids.** In case of no response from H1 bidder or if the H1 bidder refuses to accept the vehicle bid for due to any reason, the EMD shall be forfeited and offer will be extended to H2 bidder (H2 to match the rate of H1). Similar procedure shall be followed in respect of H2/H3 etc. as long as the Bank is able to get a price above the Reserve Price. Vehicle shall not be disposed off below the Reserve Price.

8. Terms and conditions

- a. The successful bidder will be required to deposit the balance bid amount after deducting the Earnest Money Deposit as mentioned above.
- b. Delivery of the sold vehicle will be given only after the completion of the RTO formalities by the buyer. This will include transfer of the registration to the purchaser and appearance of his/ her name on the NOC as the new owner and verification of KYC documents by Bank. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously.
- c. Transfer of Insurance in the name of the successful bidder will also has to be ensured. <u>In the case of 'Insurance Transfer'</u>, proportionate balance premium will be recovered from the successful bidder.
- d. Format for submission of "Personal Particulars" and the "Bid" is attached as **Annexure 'A'** & **'B'** respectively with this tender notice. The Bidder must submit the documents required to be submitted along with the bid to avoid rejection of the application.
- e. The sold vehicle shall have to be removed by the successful bidder at his own expense.
- f. Approval of sale offer is subject to Bank's internal procedure and as such participating bidders have no right to claim interest on the Earnest Money deposited by them with the Bid/Quotation/ sale offers.
- g. The Bidder has to sign each page of all the offer papers being submitted.
- h. The Bank (Central Bank of India) reserves the right to accept/ reject any tender without assigning any reason and our decision in case of doubt/ dispute shall be final and binding on both the parties.
