The interested tenderers may remain present during the offer opening process at the scheduled date and time. The offer will be valid for a period of two months from the date of receipt of offer by successful bidder to enable the office for observing all necessary formalities.

3.INSPECTION OF VEHICLE: Interested tenderers may inspect the vehicles with permission at the Central Bank of India, Zonal Office Karol Bagh at the said address on any Bank Working Day between 11:00 AM to 1430 PM up to 03 April 2023.

4.A separate bid must be submitted for each vehicle in which the bidder is interested and an envelope that must be super scribed as “bid for purchase of vehicle”. registration no. (vehicle no.). **BID WOULD BE EXCLUDING GST.**

5.Earnest Money Deposit of ₹ 10,000/- (Rupees Ten Thousand Only) for General Public and ₹ 5,000/- (Rupees Five Thousand Only) for Staff and Ex-staff shall be paid along with the offer in the form of Account Payee Demand Draft drawn in the favour of Central Bank of India and payable at New Delhi. (EARNEST MONEY DEPOSIT IS REFUNDABLE)

6. The successful bidder (H1 Bidder)has to pay the **FULL AMOUNT PLUS THE GST APPLICABLE FOR VEHICLE(GST @ 12%)** within seven days from the date of receipt of intimation (**Excluding the date of intimation**) by means of DD / Pay Order favouring Central Bank of India and payable at New Delhi . Failure to make payment in full will result in forfeiture of the offer and the EMD submitted and offer will be extended to H2 Bidder .Similar procedure will be followed in respect H2/H3 etc bidders till the Bank gets the ‘RESERVE PRICE’.

7.OTHER TERMS AND CONDITIONS:

i)The successful bidder will be required to deposit the balance bid amount **after the return of Earnest Money Deposit** as mentioned above.

ii)THE DELIVERY OF THE SOLD VEHICLE WILL BE GIVEN ONLY AFTER THE COMPLETION OF RTO FORMALITIES BY THE BUYER. In the case of ‘Insurance Transfer’, proportionate balance premium will be recovered from the successful bidder. Formats for submission of “Personal Particulars” and the “Bid” are attached as **Annexure A & B** respectively with this tender notice. The Bidder must submit the documents required to be submitted along with the bid to avoid rejection of the application.

iii)**In case vehicle/s is purchased as a scrap, vendor has to complete all the govt guidelines, rule and directions issued time to time, in relation to scrap policy. (if any individual is purchasing the vehicle as a scrap, vendor has to return chassis no. in two pieces.)**

iv)The sold vehicle/s shall have to be removed by the successful bidder in 07 days at his /her own expense.

v)The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his/her name at his/her own cost expeditiously.

vi)The Bidder has to sign each page of all the offer papers being submitted.
