- 4.A separate bid must be submitted for each vehicle in which the bidder is interested and an envelope that must be super scribed as "bid for purchase of vehicle". registration no. (vehicle no.). BID WOULD BE EXCLUDING GST.
- 5.Earnest Money Deposit of ₹ 10,000/- (Rupees Ten Thousand Only) per vehicle for General Public and ₹ 5,000/- (Rupees Five Thousand Only) for Staff and Ex-staff shall be paid along with the offer in the form of <u>Account Payee Demand Draft drawn in the favour of Central Bank of India and payable at New Delhi.</u>
