- 1. The persons/ bodies who are willing to purchase both vehicles or single vehicle may apply separately for each Vehicle. The offer letter in given format should be in sealed envelope super scribed "VEHICLE FOR SALE Reg No. _____ or before 22 Dec 2023 up to 1500 hrs.
- 2. All the application received will be placed and opened before the Tender Opening committee on 22 Dec 2023 at 1530 hrs. The purchaser may send their representative during opening time. No separate notice/information will be given for opening.
- 3. The application for purchase of the vehicles should be submitted in the prescribed format separately for each vehicle available at our office during office hours or may be downloaded from bank website www.centralbankofindia.co.in . Interested person may apply for Single vehicle or Both Vehicles in Two separate envelopes.
- 4. The Duly filled up form in the prescribed format in sealed envelope separate for each vehicle be addressed to the Zonal Head as above said address and be accompanied with Earnest Money Deposit (EMD) of Rs.5000/- for Central bank staff/ex-staff and Rs.10000/- for Remaining all persons/bodies along with application fee of Rs. 250/- (Non-refundable) per vehicle by DD drawn from any National Bank in favour of Central Bank of India, Zonal Office, Kolkata payable at Kolkata. EMD will adjusted in final submission of the amount by the bidder at time of delivery. Cheques can be accepted only in respect of serving Staff members. Application fee is waived for staff / retired-staff members.

- 5. The applicable GST is 12 % for Sale of above Vehicles.
- 6. Bank can change / cancel the tender without prior notice if require.
- 7. The purchaser can withdraw offer before opening of the Tender.
- 8. Application forms without Application Fee and EMD will be rejected.
- 9. The right for accepting or rejecting the proposal is the sole discretion of the Bank.
- 10. Highest bidder will be informed in writing with instructions to make the balance payment within 10 days of receipt of letter. Extension beyond 10 days could be considered by the Management only as an exception and in genuine cases.
- 11. The successful bidder will have to pay Balance payment (offered amount the vehicle minus EMD cost) at our office by way of Demand Draft/NEFT/RTGS or else his earnest money amount will be forfeited which please note.
- 12. In case of no response from H1 bidder, the EMD shall be forfeited and offer extended to H2 . Similar procedure shall be followed in respect to H2/H3 etc. till the bank is able to get the "RESERVE PRICE" as fixed by the Bank.
- 13. The ownership transfer will have to be completed in 30 Working days by purchaser and vehicle will be shifted / handed over after ownership transfer. If not done within time, the Vehicle will remain at the Buyer's risk until so removed and the Bank shall be entitled to recover from the purchaser the ground rent @ KMC Parking Charges per day or part of a day. Such ground rent or any other charges that may have been incurred by the Bank shall be recovered from the Buyer before the Vehicles are delivered. The vehicle will be handed over post clearance of all dues
- 14. All fees/ money regarding purchase registration, insurance, road tax, RTO fee, PUC certificate, stamp duty, legal charge, GST will be paid/ borne by purchaser. At the time the buyer gets the vehicle transferred in his name, the insurance transfer premium shall be borne by the buyer. The information on transfer of ownership will be given to Insurance Company. The vehicle will be handed over post clearance of all dues.
- 15. Tender Process/ procedure will be according to the Bank's policies. In Case of dispute any matter will be subjected to the exclusive jurisdiction of court at Kolkata.
