2. Bidder should send their bid in a sealed envelope with a DD of Rs 5000/- for Staff/ Ex-staff & Rs 10,000/- for General Public as Earnest Money Deposit (EMD) drawn in the favor of Central Bank of India, Zonal Office, Lal Darwaja, Ahmedabad. Envelope should be scribed " **BID FOR AUCTION OF VEHICLE**".
3. Application fee is Rs 500/- (Non-refundable). Application form will be available at Zonal Office and could be downloaded from web-site as may be required. However, in case the application form is downloaded, the application fee (DD for the amount Rs 500/-) and DD for EMD amount should be submitted by separate DD along with bid.
4. EMD of unsuccessful bidder will be returned.
5. Bid should be sent to the address : Zonal Office, 5th Floor, Central Bank Building, Lal Darwaja, Ahmedabad.
6. **Bid should be submitted separately for both the vehicles.**
7. Last date for receiving of bid is 29/12/2023, 1600 hrs. Tender shall be opened by a Committee on 30/12/2023 at 11.00 hrs at Zonal office.
8. Bid without Application Fee & EMD will be rejected.
9. Highest bidder (H1) will have to deposit remaining amount within 7 days. Extension beyond 7 days could be considered by the Management only as an exception and in genuine cases.
10. In case of no response from H1 bidder, the EMD deposited by the highest bidder shall be forfeited and offer extended to H2 (H2 to match the rate of H1). Similar procedure shall be followed in respect of H2 / H3 etc. till the Bank is able to get the "Reserve Price".
11. The vehicle shall be handed over to the buyer only after it is registered in the name of the buyer by RTO and documents to this effect are obtained.
