- Vehicle will be available for inspection between 10.00 am to 05.00 pm during working days w.e.f. 11/07/2024 to 18/07/2024 at Regional Office, First Floor, BSNL Building, Opp: Jail Road, Near Kuber Bhavan, Vadodara - 390 001.
- Bidder should send their bid in a sealed envelope with a DD of Rs. 5000/- for Staff/Ex-Staff & Rs. 10000/- for General Public as Earnest Money Deposit (EMD drawn in the favor of Central Bank of India, Regional Office, Vadodara envelope should be scribed ~"BID FOR AUCTION OF VEHICLE".
- Application fee is Rs. 500/- (Non-refundable). Application form will be available at Regional Office and could be downloaded from web-site as may be required. However, in case the application form is downloaded, the application fee (DD for the amount Rs. 500/-) and DD for EMD amount should be submitted by separate DD along with bid. The tender bid without application fee and earnest money will not be entertained.
- EMD of unsuccessful bidder will be returned.

- Last Date for receiving of bid is 18/07/2024, 17.00 hrs. Tender shall be opened by a Committee comprising of at least three officers headed by a Chief Manager (DRM) on 19/07/2024 at 11.00 hrs at Regional Office or any further date as per convenient of the Bank.
- BID without Application Fee & EMD will be rejected.
- Highest bidder (H1) will have to deposit remaining amount within 7 days. Extension beyond 7 days could be considered by the Management only as an exception and in genuine cases.
