## INSTRUCTION TO THE APPLICANTS

Intending contractors / vendors are requested to furnish details about their firm, technical experience, competence, and evidence of their financial standing as per enclosed format for considering their names for empanelment.

- 1.0 Application forms are invited for empanelment of experienced, reputed and competent contractors.
- 2.0 Contractors shall apply for empanelment in prescribed format, which can be down loaded from the Bank's web site www.centralbankofindia.co.in under tenders and from Govt. portal <a href="www.eprocure.gov.in">www.eprocure.gov.in</a>.
- 3.0 The application shall be signed by the person/s on behalf of the organization having necessary Authority / Power of Attorney to do so. Each page of the application shall be signed as token of acceptance of the contents mentioned therein and copy of Power of Attorney / Memorandum of association (Wherever applicable) shall be furnished along with application.
- 4.0 It is necessary that contractors / vendors must have full office set up at Pune or a full-fledged branch office at Pune if its head office / registered office is somewhere else. Preference will be given to Pune based contractors / vendors who are on the panel of Nationalized / Public Sector Banks in Pune.
- 5.0 Applicant should be empanelled with PSU/ Govt organizations in the last 3 years and providing satisfactory service. A work satisfactory certificate shall be submitted from such organizations.
- 6.0 Contractors shall also authorize the Bank to approach his Employers, Clients, Corporations, Organization, etc. to verify contractor's general reputation / competence. Selection of contractors will be based on the ability and competence required for good quality jobs to be performed by them.
- 7.0 Bank may obtain confidential reports from contractor's existing/ past clients for which the applicant shall produce the names and contact details of such clients. At least 2 clients shall be from PSU/ Govt organizations. Based on the confidential reports from your clients, application of bidder will be accepted/ rejected. Unsatisfactory report from your client may lead to rejection of your application.
- 8.0 Documentary proof with respect to the details furnished in the application form regarding eligibility criteria shall be furnished along with the application form. In this regard, **copies of the work order and completion certificate and / or such documents** shall be submitted with self-attestation. Incomplete application or application without proper proof for establishing their credentials will be rejected and no correspondence will be entertained in this regard.
- 9.0 The evaluation will be based on the experience of the professional / Contractors / vendors and their financial capabilities and may also include inspecting the works furnished by them for which, necessary co-ordination shall be made by them. Based on the details furnished and

- inspection of works, eligibility criteria, professional / contractors / vendors will be empaneled.
- 10.0 The empanelment shall be made for a specific category. However, contractor empanelled in higher category shall be eligible for the works in the lower category.
- 11.0 If information and details furnished by applicants are found to be false at any time in future or any information withheld, which comes to the notice of the Bank at later date, the empanelment of such applicant will be cancelled immediately.

- The (contractors) should have in last 3(three) years carried out (i) at least 1(one) work costing not less than the amount equal to 80% of the category applied for **or** (ii) at least 2(two) similar works costing not less than the amount equal to 50% of the category applied for **or** (iii) at least 3(three) similar works costing not less than the amount equal to 40% of the upper limit in the category applied.
- The firm (contractors) must have executed work for foreign / private / public sector banks or public / private sector organization having local office (place of application)
- ➤ The average Annual financial turnover of the firm for the last 3(three) years, ending 31<sup>st</sup> March of the previous financial year should be at least 2 times of the upper limit in the category applied.
- ➤ The contractors should have PAN and GST Numbers applicable as per Govt. Rules & Regulations.

## 15.2 For Electrical works

- The firm (Contractors) should have minimum 5 years experience in the respective field applied for.
- The (contractors) should have in last 3 (three) years carried out (i) at least 1 (one) work costing not less than the amount equal to 80% of the category applied for or (ii) at least 2(two) similar works costing not less than the amount equal to 50% of the category applied for or (iii) at least 3(three) similar works costing not less than the amount equal to 40% of the upper limit in the category applied.
- The firm (contractors) must have executed work for foreign / private / public sector banks or public / private sector organization having local office at Pune
- The average Annual financial turnover of the firm for the last 3(three) years, ending 31<sup>st</sup> March of the previous financial year should be at least 2 times of the upper limit in the category applied.
- ➤ The contractors should have PAN and GST Numbers, Government Electrical License applicable as per Govt. Rules & Regulations.

### 3.4. For Air conditioning works

- ➤ The firm (Contractors) should have minimum 5 year experience in the sale and servicing, maintenance of various types of air conditioners and plants.
- The (contractors) should have in last 3 (three) years carried out (i) at least 1 (one) work costing not less than the amount equal to 80% of the category applied for or (ii) at least 2(two) similar works costing not less than the amount equal to 50% of the category applied for or (iii) at least 3(three) similar works costing not less than the amount equal to 40% of the upper limit in the category applied.
- ➤ The firm (contractors) must have executed work for foreign / private / public sector banks or public / private sector organization having local office at Pune
- ➤ The average Annual financial turnover of the firm for the last 3(three) years, ending 31<sup>st</sup> March of the previous financial year should be at least 2 times of the upper limit in the category applied.
- ➤ The contractors should have PAN and GST Numbers, Government Electrical License applicable as per Govt. Rules & Regulations.
- ➤ The contractor shall be authorized dealer for at least one of the reputed manufacturers like Voltas, Carrier, Diakin, Hitachi, Blue star.

## GUIDELINES FOR SUBMISSION OF APPLICATION FORM FOR EMPANELMENT OF CONTRACTORS

- 1. The application shall be downloaded from the Bank's website as given in advertisement.
- 2. Application form for empanelment shall be submitted in sealed envelope super scribing 'Application for Empanelment as Contractors For .......Category......
- 3. The contractors who intend to apply for more than one category have to apply for each category using separate application form and fee.
- 4. The application shall be submitted along with a complete tender document and strictly in the format as mentioned along with the supporting documents.
- 5. The application shall be signed by the person/s on behalf of the organization having necessary Authority/ Power of Attorney to do so. Each page of the application shall be signed and copy of Power of Attorney / Memorandum of association (Wherever applicable) shall be furnished along with application.
- 6. If the space in proforma is insufficient for furnishing full details, such information may be supplemented on separate sheet stating therein the part of proforma and serial number. Separate sheets may be used for each part of application. While filling up the application with regard to list of important projects completed or on hand the applicant shall only include major works handled by the firm.
- 7. The ability and competence of the applicant to render required services within the specified time frame will be a major factor while deciding the empanelment of contractors.
