#### **GENERAL TERMS & CONDITIONS**

- Opening of Tenders & Validity Period: The bids are to be submitted within the specified Date & Time. The interested tenderers may remain present during the offer opening process at the scheduled date and time. The offer will be valid for a period of two weeks from the date of receipt of offer by successful bidder to enable the office for observing all necessary formalities.
- 2. **Inspection of Items**: Interested tenderers may inspect the Items with permission at the Central Bank of India, Mumbai Metropolitan Zonal Office on 11.08.2025 between 1100 Hrs to 1300 Hrs.
- 3. The bid must be submitted in an envelope that must be super scribed as 'Bids for disposal of Furniture & Fixture Items of Standard Building, Dr. D. N. Road" not later than the specified date and time. Unsigned bids, incomplete quotations, corrections, alterations or overwritten figures and words on the bids shall be liable to rejected. The bids will be opened on the specified date and time in the Committee in the presence of bidders who may be present.
- 4. Reserve Price: Bids below 'Reserve Price' will not be considered. The 'Reserve Price' will be declared at the time of opening of the Bids. The materials would be sold to the Highest Bidder on "As Is Where Is" basis and "No Complaint" basis. In case of no response from H1 bidder or if the H1 bidder refuses to accept the Item bid due to any reason, the H1 bidder's Demand Draft shall be forfeited and offer will be extended to H2 bidder (H2 bidder has to match the rate of H1). Similar procedure shall be followed in respect of H2/ H3 etc, as long as the Bank is able to get a price above the Reserve Price. Item(s) shall not be disposed off below the Reserve Price.
- 5. The Bidders need to submit the quoted amount inclusive of GST in form of Demand Draft in the name of Central Bank of India, Payable at Mumbai. Offers without the Demand Draft will be rejected without assigning any reason and no correspondence towards the same will be entertained by Bank.
- 6. In case any discrepancy is observed between the amount(s) stated in words and figures, the higher of the two will be considered.
- 7. The bidder in their bid shall clearly mention the PAN/ GST. The Bidder has to sign each page of all the offer papers being submitted.
- 8. Participation and bidding in this auction shall be treated as conclusive evidence of the fact that the bidder has inspected the items and satisfied in all respects i.e. quantity, quality, conditions of the items and the Bank does not give assurances of the quality, quantity and measurement.
- 9. The successful bidder will be intimated through Telephonic conversation/ e-mail. Accordingly, his/ her Demand Draft (submitted with the Bank) will be materialised.

- 10. The successful bidder has to remove the materials within two working days post intimation, by making their own arrangements for dismantling, lifting, loading and transportation. Once the money has been paid to the Bank, the security of the materials will lie with the successful bidder and no responsibility shall be taken by the Bank. The successful bidder needs to take delivery at his own costs without causing damage to the surrounding and physical structure of the Bank premise. The sold Item(s) shall have to be removed by the successful bidder at his own expense.
- 11. In case the whole or any part of the materials remains un-cleared even after two days, the bidder shall have no claim on the goods remaining un-cleared and the Bank will take suitable action to dispose off the said materials with no reference to the bidder. No amount will be refunded. The successful bidder shall remove the materials identified for him/her completely leaving no residual materials at the site. He/ She may not auction the material at the site or sort out the same on the site.
- 12. The Demand Draft of the unsuccessful bidders will be returned either by physically in person or by Speed Post/ Register Post to the address mentioned by the bidder. Hence, the participants have to mention the correct address.
- 13. No request for any further extension of the quotations date shall be entertained. Delayed/incomplete quotations received will not be entertained.
- 14. No complaint regarding quality/ Quantity will be entertained after sale.
- 15. Approval of sale offer is subject to Bank's internal procedure and as such participating bidders have no right to claim interest on the Demand Draft deposited by them with the Bid/Quotation/sale offers.
