তদুপায় সংশ্লিষ্ট কল্যাণীতাপন/জমিনদারগণ/স্বত্বদাতাগণকে ও পরে উল্লিখিত অর্থাৎ সর্বশেষ তারিখ পর্যন্ত সুন ও অনুলিখিক বরজ সমেত ই-নিলামের নির্ধারিত তারিখের আগে আলাদা দেওয়ার হুকুম জারি করা হচ্ছে যার অন্ত্যাহ হলে সম্পত্তি নিলাম/বিক্রি করা হবে এবং এর পরে কোনও অর্থাৎ বরজা থাকলে তা সুন ও মাপল-সহ আলাদা করা হবে।
