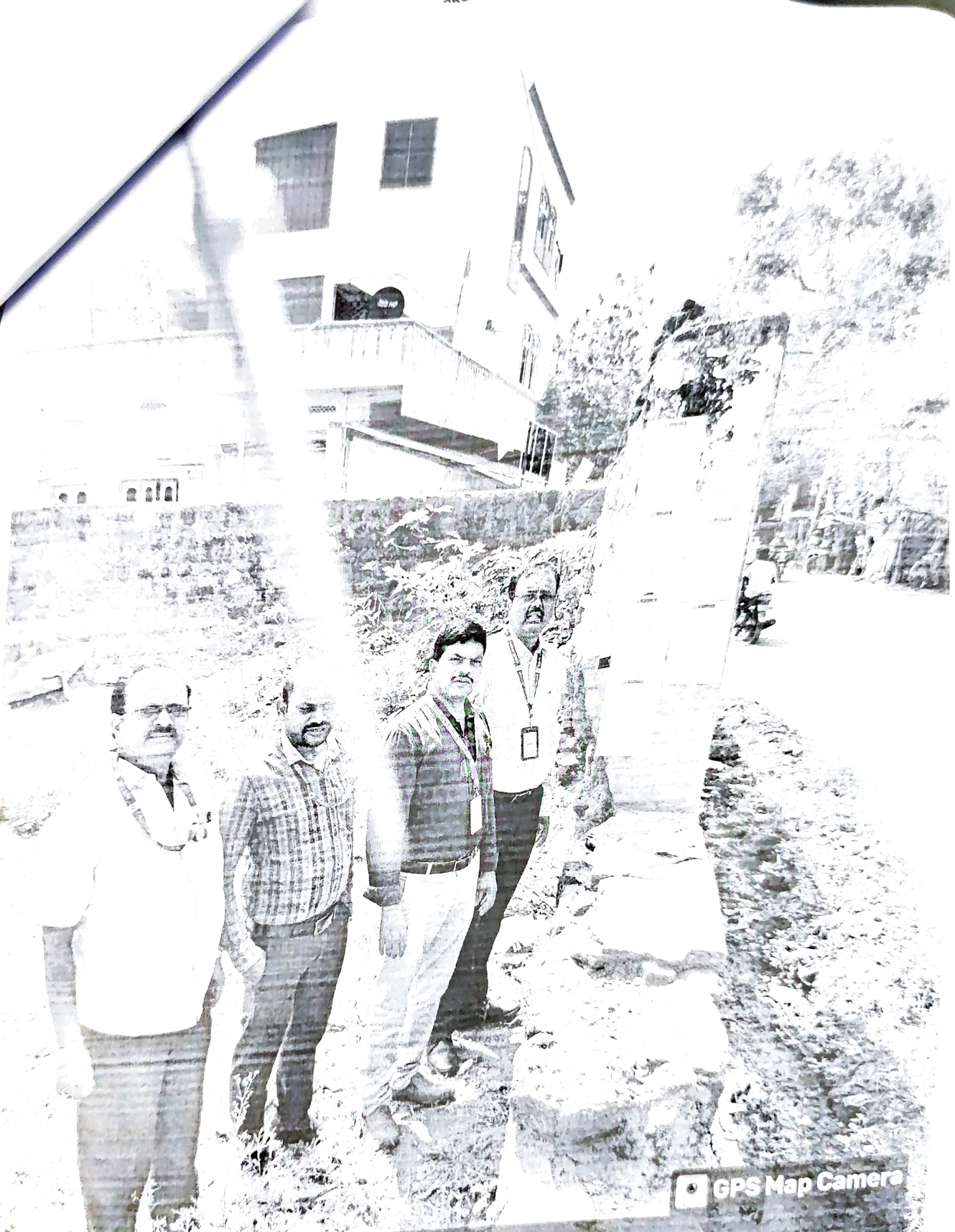


GPS Map Camera
