Addressing separate rallies in Haryana and Punjab ahead of the sixth phase of polls on May 25, Prime Minister Narendra Modi on Thursday accused the Congress and its INDIA bloc allies of dividing the country into three nations, including two Muslim ones, to “appease their vote bank”, and saying Muslims have

the first right on India. He said the bloc wants to snatch the reservation guaranteed by the Constitution to the SCs, STs, and OBCs and give it to those who do “vote jihad”. Campaigning for Dharambir Singh, the BJP’s candidate for the Bhiwani-Mahendragarh Lok Sabha seat in Haryana, Mr. Modi, referring to a recent High Court order cancelling five lakh OBC certificates in West Bengal, said the re-

servation meant for the OBCs is being distributed to the “intruders”, exposing the anti-quota mentality of the INDIA bloc. The PM said he is the watchman of the rights of the deprived and has come to assure them that no one can take away their reservation as long as he is alive. Mr. Modi said the Congress, if it has its way, will arrest people for even uttering the word “Ram”. He said it wants to obliterate

“Ram” from the country. The PM said the INDIA bloc, anticipating its defeat, has started accusing the Election Commission of delaying the release of voter data to find a scapegoat for its imminent loss. “Every vote cast for the Congress will be a waste, since it can never form a government,” he said, adding that INDIA bloc parties are saying they will have five PMs in five years if voted to power. “INDI Al-

liance only spreads the politics of communalism, casteism, and dynasty”. ‘Ineffective CM’ During a rally in support of BJP’s Patiala candidate Preet Kaur, Mr. Modi targeted the Bhagwant Mann-led AAP government in Punjab and said the sand mining and drug mafia are having a free run. He said the “*ka-gazi* (ineffective) CM” is busy attending the party’s “Delhi Darbar”.

# ‘Kerala Governor trying to saffronise higher education’

# In Bengal’s Tamluk LS seat, jury’s out as former judge is up against TMC, CPI(M) rivals

“We are Team Tamluk and we have to keep the BJP at bay. Do I have the blessings of the mothers and sisters of Moyna?” asked 28-year-old Debangshu Bhattacharya of the All India Trinamool Congress to a growing crowd of villagers under a scorching May sun, referring to his rival candidate as a “fake judge”. The audience, mostly women, burst into a cheer, clapping and raising their hands to show their support. With two days to go for the sixth phase of the polls, villagers of Moyna in Tamluk constituency lined up excitedly on Thursday at the village centre to meet the TMC candidate locked in a bitter contest with former Calcutta High Court judge and BJP candidate Abhijit Gangopadhyay. While Mr. Bhattacharya campaigned in the constituency, Mr. Gangopadhyay remained out of sight, due

to a 24-hour censure by the Election Commission of India following his controversial remarks on Chief Minister Mamata Banerjee. Before Mr. Gangopadhyay joined hands with the BJP, he caught the people’s imagination as the Calcutta HC judge who ordered a CBI probe into the alleged discrepancies in the State’s teacher recruitment process and whose rulings led to the arrest of a senior TMC Minister and three MLAs. Mr. Gangopadhyay earned the epithet of a “crusader against corruption”. His decision to join politics soon after his resignation from the judiciary, however, ignited doubts over his judgments as a judge. Women’s vote According to Mr. Bhattacharya, this year’s Lok Sabha election results in West Bengal, including in Tamluk, would be determined by the votes of women. “Abhijit Gangopadhyay is anti-women, he did not even

spare the Chief Minister,” Mr. Bhattacharya said. Mr. Gangopadhyay declined to comment. Tamluk spans seven Assembly segments across coastal Purba Medinipur district in south-eastern Bengal and includes critical seats like the industry-rich Haldia and the contentious Nandigram. The third candidate, 30-year-old advocate Sayan Banerjee of the Communist Party of India (CPI-M), is certain that his advantage is the frustration of voters over the mud-slinging among his two rival parties. “People are fed up... they want change,” he said. Mr. Banerjee said a pressing issue in the constituency is that of Nandigram’s youth, who, according to him, were forced to become migrant labourers due to unemployment in the area. “The industrial belt at Haldia, the thermal plant at Kolaghat were all developed by the Left. That gives me an advantage,” he added.

# If you have any respect for me, come back, Gowda warns Prajwal

Former Prime Minister and JD(S) supremo H.D. Deve Gowda on Thursday issued a warning to his grandson Prajwal Revanna, through a letter posted on X, asking him to return to India and surrender to the police, or face his anger and that of his family members. In the letter with the title: “My warning to Prajwal Revanna”, Mr. Gowda said, “This is not an appeal that I am making, it is a warning that I am issuing. If he does not heed to this warning, he will have to face my anger and the anger of all his family members. The law will take care of the accusations against him, but not listening to the family will ensure his total isolation. If he has any respect left for me, he has to return immediately.” “... I have already said that he should be given the harshest punishment under the law if found guilty,” stated the two-page letter.


