Step 1: Bidder/Purchaser registration: Bidder to register on e-Auction Platform <a href="https://ebkray.in/">https://ebkray.in/</a> using his/her mobile number and email-id

Step 2: KYC verification: As a part of e-KYC the documents will be verified by the system.

**Step3: EMD amount:** The interested Bidders/Purchasers has to transfer the EMD amount using online mode (i.e. NEFT/Transfer/UPI/Net Banking) in his Global EMD Wallet well in advance.
