Terms and condition for E-Auction

The auction will be “Online E-auction” through **e-bkroy portal**

1. **Date and Time for auction: 16.07.2025 between 04:00 PM To 05:00 PM (With auto extension clauses in case of bid in last 5 minutes before closing).** E-Auction is being held on “As is where is”, “As is what is” and “Whatever there is” basis.
2. Auction/Bidding shall only through “Online Electronic Bidding” through the website / portal [e-bkroy](#) and property details is also available at [e-bkroy](#). Bidders are advised to go through the website for detailed terms and part in the e-auction sale proceedings.
3. Bidders has to complete following formalities well in advance:-
Step 1- **Bidder/ Purchaser Registration:** Bidder to register on e-Auction portal [e-bkroy- PSB Alliance](#) using his mobile number and email-id.
Step 2: **KYC Verification:** Bidder to upload requisite KYC documents. KYC documents shall be verified by e-auction service provider (may take 2 working days)
Step 3: **Transfer of EMD amount to his Global EMD Wallet:** Online/ off-line transfer of fund using NEFT/Transfer, using challan generated on e-Auction portal.
Step 1 to Step 3 should be completed by bidder well in advance, before e-Auction date.
4. **Earnest Money Deposit (EMD) as mentioned above shall be paid online through NEFT/RTGS Transfer in bidders Global EMD Wallet.**
